3. CONCEPT REVIEW: TWO-LOT SUBDIVISION: Thomas and Mary Alice May (TMT), 5911 West Lake Rd., Conesus, tax map #109.44-1-19.1

The Mays wish to tear down their existing house and rebuild on the same footprint. This is located south of the Beachcomber, which they own. However, in order to subdivide into two lots, a variance would be needed from the ZBA. Lot width for LSR is 50 ft – they lack 15 feet. CEO Maxwell explained the project and also its implications as the Mays also have a Dock & Mooring Permit as part of their business. Letters of support from neighbors were presented to the Planning Board and then returned.

4. LARGE SCALE SOLAR BATTERY STORAGE - CONTINUED.

Planning Board members and CEO Maxwell continued to discuss whether to have a separate law or whether to make it part of the existing Town Solar Law. Members had not been in favor of making it separate. However, in view of the fact that two members were not present, and after much discussion, it was decided to table this agenda item until the September meeting. CEO Maxwell reported that there are two possible solar farms coming to Groveland soon. One is Brady's which is located near Peter Dolan's and the other is Merrimac's on Abele Road.

Frederick Ingalls, Jr. made a motion to table this agenda item until the September meeting to allow for participation of the entire Planning Board, including the two absent members.
