### 3. CONCEPTUAL SUBDIVISION- 5380 Scottsburg Road

Chair Seth Burnette invited Jacob Wengerd (representing Eli Shetler) and Eli Yoder to explain what they were looking to do. The purpose of the subdivision is to divide the existing lot to build a new school. The new school will have approximately 20 kids that currently have to go to the school in Sparta.

The building permit has already been issued for the school, but Code Enforcement Officer Ron Maxwell wanted the school to be discussed for the boards input. The board reviewed the informal plans for the school and did not see any issues. The County has also approved the septic system for the project. CEO Ron Maxwell explained to the board that the subdivision does not need to be finalized for the school to be built.

In review of the subdivision plans the board noticed a small building on the property line between the Shetler and neighboring property to the South. Jacob and Eli stated that the building is not stable. CEO Ron Maxwell recommended that when their attorney updates
