**Solar Law –** Chair Burnette and CEO Maxwell attended a recent Town Board Meeting where the purposed Solar Law was discussed. There are some potential changes that were

discussed. There was also a review of the letter received from county. It was discussed at length and agreed upon that this board does not want to be as restrictive on the farmer as was recommended by Livingston County. Additional notes are as follows:

- 2. The Board reviewed and feels they adequately covered this concern. The Board plans to encourage the applicant to review the farmland protection plan before building and may recommend building on less viable farmlands.
